- 2. TABS Regional Conferences The recommended logistics for the TABS Regional Conferences in 2014 were discussed as a state map listing the TABS schools was shown.

Host schools for 2014 One day regional conference are North: Temple Christian and Nazarene Christian Academy; Central: Hyde Park Baptist Schools and San Marcos Academy (2/17/14); West: Southcrest Christian School (2/17/13); and South: Fort Bend Christian Academy(2/7/13). Dates are selected by the host school. Schools have the option to attend any conference.
